The Electoral Register is the list of everyone who is registered to vote. You can only vote at elections if your name is included. Once published the register is updated each month following receipt of applications.

If you have recently moved or have been missed off the register you can get your new details put onto the register by completing this application and returning the form to the Electoral Registration Officer.

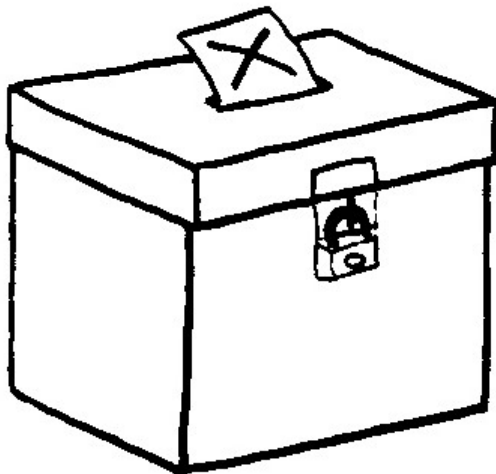
**Can I register?**

You must be:

- ✓ over 16 (but cannot vote until your 18<sup>th</sup> birthday)
- ✓ a British or Commonwealth citizen, or
- ✓ a citizen of the Irish Republic or of another EU member state
- ✓ resident at an address in Warrington.

**The Full Register**

The full register lists everyone who is entitled to vote and their addresses. You can inspect, under supervision, the register by arranging an appointment at the Town Hall. Only certain people and organisations can have copies of the full register and they can only use it for specified purposes. The main use of the full register is for elections and referendums, but it can also be used for other purposes such as the prevention and detection of crime and is used by credit reference agencies. It is a criminal offence not to comply with the regulations.



**The Edited Register**

The edited register leaves out the names and addresses of people who have asked for them to be excluded from this version of the register. The edited register can be bought by any person, company or organisation and can be used for any purpose. If you do not wish to appear in the edited register, please tick the relevant box on the application form.

Under the Representation of the Peoples Act, any application to be included on the electoral register is subject to public inspection to allow for objection. At the end of this 5 day period if no objection has been received the applicant may be added to the register in accordance with the statutory timetable set out below for 2011. **You will receive a confirmation letter of your inclusion on the register.**
